STEP 1 OF 4

Attention! This ProClip consists of two parts. Part 1 - ProClip attaching part (the smallest part)Part 2 - ProClip face plate. Clean the dashboard surface where the ProClip will be attached with the enclosed alcohol pad. Press the thin end of the enclosed gap openers into the gap between the center console panel and the console edge, to widen the gap. Peel off the cover of the adhesive tape on Part Place the thin edge of Part 1 against the gap between the gap openers.



STEP 2 OF 4

Press the thin edge firmly into the gap and at the same time: bend Part 1 to the right until you see or hear/feel it click into place. Pull out the gap openers.



STEP 3 OF 4

Press a screwdriver (Philips) firmly through the predrilled holes in Part 2 to open them up. Peel off the cover of the adhesive tape on Part 2. Place Part 2 onto Part 1 so the holes match and the adhesive tape on Part 2 is on the left side. Do not press the tape to the center console panel frame yet. Screw Part 2 onto Part 1 using the enclosed screws. Right before you tighten the screws press the ProClip to the right with your thumb for optimal adjustment of the mount. Then press the adhesive tape on the left side of Part 2 to the center panel. Hold the ProClip in that position and tighten the screws.



STEP 4 OF 4

The ProClip Mount is in place.
