STEP 1 OF 4

Use the enclosed alcohol pad to clean the area where the ProClip is to be installed. Press the thin end of the enclosed gap openers into the seam/gap between the dashboard and the center console panel edge, to widen the gap. Peel off the cover of adhesive tape on the ProClip.



STEP 2 OF 4

Align the upper left corner of the angled edge on the left side of the ProClip as shown with the white stripe in the picture. Press the angled edge firmly into the gap between the two panel sections.



STEP 3 OF 4

Press firmly forward on the right side of the ProClip so it flexes towards the gap openers and hooks around the panel edge between the gap openers. Press until you see or hear/feel it click into place. Pull out the gap openers.



STEP 4 OF 4

The ProClip Mount is in place.
