STEP 1 OF 4

Press the thin end of the enclosed gap openers upwards into the seam between the console edge and the sidewall storage box, to widen the gap. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Hook the angled edge on the lower part of the ProClip into the gap between the gap openers. Then pull out the gap openers.



STEP 2 OF 4

Press the thin end of the gap openers into the seam between the console edge and the center console sidewall, to widen the gap.



STEP 3 OF 4

Push the ProClip towards the center console sidewall so the angled edge goes into the gap between the gap openers. Press firmly down on top of the ProClip to make sure the angled edge is all the way into the gap. Pull out the gap openers.



STEP 4 OF 4

The ProClip Mount is in place.
