Nissan GTR 2009-2016



DO NOT attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash.

STEP 1 OF 4

Press the thin end of the enclosed gap opener into the gap between the center console edge and the padded part of the sidewall, to widen the gap.



STEP 2 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Hold the ProClip at an almost 90 degree angle towards the sidewall and press the angled edge on the right side of the ProClip into the gap above the gap opener. Pull out the gap opener.



STEP 3 OF 4

Press the thin end of the opener into the seam/gap in the center console edge, to widen the gap. Then flip the ProClip towards the center console so the angled edge on the right side of the ProClip hooks behind the sidewall edge. Place your index fingers behind the ProClip face plate. Pull so the ProClip flexes towards you and hook the angled edge into the gap above the gap opener. Pull out the gap opener.



STEP 4 OF 4

The ProClip Mount is in place.
