DO NOT attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash.

STEP 1 OF 4

Use the enclosed alcohol pad to clean the area where the ProClip is to be installed. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the thin curved edge into the seam/gap between the panel frame surrounding the air vent and the padded part of the dashboard.



STEP 2 OF 4

Press forward and then flip the ProClip down so the curved edge on the upper part of the ProClip hooks behind the panel surrounding the air vent. Then press the thin end of the enclosed gap opener into the seam/gap between the dashboard and the dashboard overhang next to the ProClip, to widen the gap.



STEP 3 OF 4

Place your index finger on the lower inside of the ProClip. Pull down and hook the angled edge into the seam/gap next to the gap opener.



STEP 4 OF 4

Place your finger underneath the lower part of the ProClip and push upwards to make sure the angled edge is all the way into the gap. The ProClip is now in place as shown in the overview picture above.

Returns

All returns must be made within thirty (30) days of the delivery date and include proof of purchase, a copy of your original order, or invoice.
