## STEP 1 OF 4

This ProClip is divided into two parts: Part 1: The attaching part (the smallest part) and Part 2: The ProClip faceplate (the big part with the holes in). First, press the thin end of the enclosed gap openers into the gap between the center console panel frame and the console edge, to widen the gap.



## **STEP 2 OF 4**

Peel off the cover of the adhesive tape on Part 1. Place the thin edge of Part 1 into the gap between the two gap openers. The tape on Part 1 should be facing the passenger side. Press the thin edge firmly into the gap and at the same time: bend Part 1 to the right until you see or hear/feel it click into place. The adhesive tape will attach to the console edge. Pull out the gap openers.



### **STEP 3 OF 4**

Press a screwdriver (Philips) firmly through the pre-drilled holes in Part 2 to open the holes. Peel off the cover of the adhesive tape on Part 2. Place Part 2 onto Part 1 so the holes match. Do not press the tape to the center console panel frame yet. Screw Part 2 onto Part 1 using the enclosed screws. Right before you tighten the screws press the ProClip to the right with your thumb for optimal adjustment of the mount. Then press the adhesive tape on the left side of Part 2 to the center panel. Hold the ProClip in that position and tighten the screws.



## **STEP 4 OF 4**

The ProClip Mount is in place.
