GAP OPENER

Doing so makes it more difficult to install the mount to the dash. **Also**, our installation instructions are often printed prior to the last year of a ProClip mount listing. STEP 1 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the thin end of the enclosed gap opener into the gap between the two dashboard panel sections, to widen the gap.



STEP 2 OF 4

Place or hook the angled edge on the lower part of the ProClip around or into the upper air vent edge



STEP 3 OF 4

Press on the upper part of the ProClip so it flexes forward and the angled edge hooks into the gap next to the gap opener. Then press down on top of the ProClip, by the gap opener, to make sure the angled edge is all the way into the gap. Pull out the gap opener.



STEP 4 OF 4

The ProClip Mount is in place.
