STEP 1 OF 4

Press the thin end of the enclosed gap opener into the seam/ gap in the console sidewall, to widen the gap.



STEP 2 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the thin end of the angled edge on the left side of the ProClip into the gap between the CD player and the surrounding panel frame.



STEP 3 OF 4

Place your thumb on the right front side of the ProClip (behind the face plate). Push so the ProClip flexes forward and the angled edge goes into the gap above the gap opener. Press until you see or hear/feel it click into place. Pull out the gap opener.



STEP 4 OF 4

The ProClip Mount is in place.
