STEP 1 OF 4

Press the thin end of the enclosed gap opener into the gap between the console edge and the center console panel frame, to widen the gap. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the angled edge on the upper part of the ProClip upward into the gap next to the gap opener. Pull out the gap opener,



STEP 3 OF 4

Press the lower part of the ProClip upward/forward and hook the angled lower edge into the gap between the air vent and the surrounding panel frame.



STEP 4 OF 4

The ProClip Mount is in place.

Returns
