## **STEP 1 OF 4**

Press the thin angled edge of the enclosed gap opener into the gap between the air vent and the surrounding frame, to widen the gap. Peel off the cover of adhesive tape on the ProClip.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.



## **STEP 2 OF 4**

Press the angled edge on the upper part of the ProClip upward into the gap between the air vent and the surrounding frame. Then press the lower part of the ProClip upward and hook the angled edge into the gap next to the gap opener. Press downward on the lower part of the ProClip so the angled edge goes all the way into the gap.



### **STEP 3 OF 4**

Pull out the gap opener.



## **STEP 4 OF 4**

The ProClip Mount is in place.

## Returns
