STEP 1 OF 4

Press the thin end of the enclosed gap openers into the gap between the dashboard and center console panel frame, to widen the gap.



STEP 2 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Place the front part of the ProClip around the dashboard edge.



STEP 3 OF 4

Press firmly forward on the upper part of the ProClip so it flexes forward and the angled edge hooks around the panel edge between the the gap openers. Press until you see or hear/feel click into place. Pull out the gap openers.



STEP 4 OF 4

The ProClip Mount is in place.

Returns
