DO NOT attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash.

STEP 1 OF 4

This ProClip consists of two parts: Part 1: The small block with curved lip. Part 2: The ProClip Mount with faceplate (the larger part of the two provided). First, loosen (do not remove) the two right side torx screws on the front dash panel (pictured above). Then widen the seam with the enclosed gap opener by inserting the thin edge into the seam (pictured above). This may be difficult so start at the far right side of the seam, once inserted slide it to the left until it reaches the needed location.



STEP 2 OF 4

Next, peel off the yellow cover of adhesive tape on all parts. Insert the curved lip or edge into the gap to the left of the gap opener. (Pictured above) The tape should be facing up at first and then rotate part 1 upward to draw the lip down into the seam. Before adhering it to the dash please make sure the holes line up with part 2 (the larger part). You can slide part 1 left and right on the seam in order to match the holes with parts 1 and 2.



STEP 3 OF 4

Part 2, insert the thin curved edge into the panel seam (the adhesive strip should sit behind the panel). As pictured above you can use your left hand to pull the panel towards you in order to provide a gap for placement of the ProClip. Then, rotate the right side of the ProClip back toward part 1, match the holes on the right side of part 2 with the holes on part 1. There are lines on top of part 1 to help locate the holes for matching. Use the enclosed screws to attach part 2 to part 1. Draw the screws tight but be careful not to over tighten.



STEP 4 OF 4

Go back to the 2 torx screws on the front dash panel and tighten the screws you loosened in the first part of the installation. The ProClip should be firmly in place once the front panel screws are tightened. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.

Returns

All returns must be made within thirty (30) days of the delivery date and include proof of purchase, a copy of your original order, or invoice.
