STEP 1 OF 4

Press the thin end of the enclosed gap openers into the seams/gaps in the dashboard as shown in the picture, to widen the gaps.



STEP 2 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the angled edge on the right side of the ProClip into the gap above the gap opener.



STEP 3 OF 4

Press firmly forward on the left side of the ProClip so the angled edge hooks into the gap above the gap opener. Pull out the gap openers.



STEP 4 OF 4

The ProClip Mount is in place.
