STEP 1 OF 4

Press the thin end of the enclosed gap opener into the gap between the center console panel frame and the console edge, to widen the gap. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Hook the angled edge on the right side of the ProClip around the center console edge.



STEP 3 OF 4

Place your index fingers underneath the ProClip and your thumbs on top of the ProClip. Pull the ProClip slightly towards you. Hook the angled edge over the console edge and into the gap above the gap opener. Pull out the gap opener.



STEP 4 OF 4

The ProClip Mount is in place.
