GAP OPENER

STEP 1 OF 4

Press the thin end of the enclosed gap opener into the gap between the console edge and the vent frame panel, to widen the gap. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Insert the lower grooved edge of the ProClip into the seam next to the gap opener. Pull out the gap opener.



STEP 3 OF 4

Using your thumb under the lower part of the ProClip and your fingers on the upper part of the ProClip, flex the ProClip so the top angled edge goes into the seam between the inner vent and upper vent frame panel. You might need to wiggle the ProClip a little to get the angled edge into the seam as it is a tight upper seam. Listen for the ProClip to click into place.



STEP 4 OF 4

The ProClip Mount is in place.
