STEP 1 OF 4

Press the thin end of the enclosed gap opener into the seam/gap in the front facing side of the center console pillar, to widen the gap.



STEP 2 OF 4

Note: This is a very tight seam. It might be easiest to insert the gap opener at the very top of the seam or at the lowest point. See photo. Feel free to use both provided gap openers if needed.



STEP 3 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Place the angled edge on the left side of the ProClip around the console pillar back edge.



STEP 4 OF 4

Press firmly forward on the right front side of the ProClip so the angled edge on the right side flexes forward and hooks into the seam/gap above the gap opener. Press the angled edge all the way into the gap using your fingers, and then pull out the gap opener.

Returns
