STEP 1 OF 4

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the thin end of the enclosed gap opener into the gap between the instrument panel and the vertical panel frame around the instruments, to widen the gap. See photo for location.



STEP 2 OF 4

Press the angled edge on the right side of the ProClip into the gap below the gap opener.



STEP 3 OF 4

Press the thin end of the enclosed gap opener into the gap between the panel surrounding the navigation/information screen and the vertical panel frame, to widen the gap.

Push firmly on the right side of the ProClip so the angled edge on the left side flexes towards the navigation screen and hooks around the vertical panel edge below the gap opener. Pull out the gap opener.



STEP 4 OF 4

The ProClip Mount is in place.
