## **STEP 1 OF 4**

Peel off the cover of adhesive tape on the ProClip. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the angled edge on the upper part of the ProClip into the seam between the dashboard ledge and the thin panel below the navigation screen panel. Then flip the ProClip downward so the lower angled edge on the ProClip hooks behind the panel.



## **STEP 2 OF 4**

Push upward on the bottom part of the ProClip so it flexes upward. Let the ProClip rest on top of the air vent panel.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



### **STEP 3 OF 4**

Press the thin end of the enclosed L shaped gap opener into the gap between the center console and the air vent panel next to the ProClip, to widen the gap.

Then press firmly forward on the lower part of the ProClip so the angled edge goes into the gap next to the gap opener.

Note: If the gap is tight pull the panel slightly towards you using the gap opener while pushing forward on the ProClip. Push until you see or hear/feel it click into place. Pull out the gap opener.



## **STEP 4 OF 4**

The ProClip Mount is in place.
