STEP 1 OF 4

Press the enclosed gap openers into the gap between the center console panel and the dashboard, to widen the gap.

Peel off the cover of adhesive tape on the ProClip. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the L-shaped angled upper part of the ProClip into the gap between the gap openers.



STEP 2 OF 4

Press the ProClip downward so the edge goes all the way into the gap. Remove the gap openers.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 3 OF 4

Press the angled lower part of the ProClip into the gap below the panel surrounding the air vents.



STEP 4 OF 4

The ProClip Mount is in place.
