STEP 1 OF 4

Press the thin end of the enclosed gap opener (use 2 if needed) into the gap between the console edge and the center console panel frame, to widen the gap. Peel off the cover of adhesive tape on the ProClip.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the lower edge of the ProClip into the gap dividing the center console. Press the lower edge all the way in to the gap at the same time as you press the upper part of the ProClip upward/forward.



STEP 3 OF 4

Hook the angled upper edge of the ProClip into the gap next to the gap opener. Remove the gap opener.



STEP 4 OF 4

The ProClip Mount is in place.
