STEP 1 OF 4

Press the thin end of the enclosed gap opener into the gap between the padded part of the dashboard and the wood grain panel, to widen the gap. (See photo for location.)

Remove the covering from the tape.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the grooved edge on the upper part of the ProClip into the gap next to the gap opener. Press until you see or hear/feel it click into place.

Note: It might be easier to angle the ProClip upward a little to angle the edge into the opening.



STEP 3 OF 4

Press the thin end of the gap opener into the gap between the padded console sidewall and the center panel frame, to widen the gap.

This seam is tight so push firmly forward on the left side of the ProClip face plate with your thumb so the left grooved edge of the ProClip goes into the gap above the gap opener. Press until you see or hear/feel it click into place

Pull out the gap openers.



STEP 4 OF 4

The ProClip Mount is in place.

Returns
