STEP 1 OF 4

Press the thin end of the enclosed gap opener into the gap between the center console panel frame and the padded console edge, to widen the gap.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the angled edge on the left side of the ProClip into the gap below the gap opener.

Pull out the gap opener.



STEP 3 OF 4

Press the thin end of the gap opener into the gap between the console sidewall and the padded part of the dashboard, to widen the gap. (See photo)

Push firmly forward on the right side of the ProClip face plate with your thumb so the angled edge on the right side of the ProClip flexes forward and hooks into the gap next to the gap opener.



STEP 4 OF 4

Press in on the ProClip to make sure it is all the way into the seam.

Pull out the gap opener.
