## **STEP 1 OF 4**

Press the thin end of the first enclosed gap opener into the gap between the padded dashboard ledge and the upper information screen panel frame, to widen the gap. Press the thin end of the second gap opener into the gap between the air vent panel frame and the padded dashboard edge, to widen the gap. (See photo for locations.)



## **STEP 2 OF 4**

Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press firmly forward in the center of the ProClip so the lower grooved edge goes into the gap next to the lower gap opener. Press until you see or hear/feel it click into place.



### **STEP 3 OF 4**

Press down on top of the ProClip with your fingers and firmly forward with your thumb so the grooved edge on the top part of the ProClip goes into the gap next to the gap opener. Press until you see or hear/feel it click into place.

If the mount appears too short to fit, simply adjust the mount to the right a little where the dash is more narrow and the mount will fit with no issues.

Pull out the gap openers.



## **STEP 4 OF 4**

The ProClip Mount is in place.
