STEP 1 OF 4

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the gap between the padded part of the dashboard and the silver trim under it, to widen the gap.

Then, open the glove compartment door.



STEP 2 OF 4

Remove the cover from the adhesive tape on the ProClip. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position.

Press/hook the angled lower edge of the ProClip around the lower dashboard edge. (See photo.)



STEP 3 OF 4

Press the upper part of the ProClip forward so the angled upper edge hooks into the gap next to the gap opener. Then press down on top of the ProClip to make sure the angled edge goes all the way into the gap. Remove the gap opener.

Close the glove compartment door.



STEP 4 OF 4

The ProClip Mount is in place.
