STEP 1 OF 4

Press the thin end of the enclosed gap opener into the upper frame around the center console and the top tray, to widen the gap.

Peel off the cover of adhesive tape on the ProClip.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 2 OF 4

Insert the thin S shaped angled edge under the thicker part of part 1 of the ProClip into the opened seam next to the gap opener.

Pull out the gap opener.



STEP 3 OF 4

Press down on the front part of the ProClip until the tape on the front edge flexes down and onto the top tray edge. Press the ProClip onto the top tray edge so the tape adheres to the tray edge.



STEP 4 OF 4

Using the included screws, attach the face plate by inserting the screws through the two larger face plate holes and into the pre-drilled holes in the thicker part of part 1.

Returns
