GAP OPENER

STEP 1 OF 4

Clean the area where the ProClip will attach.

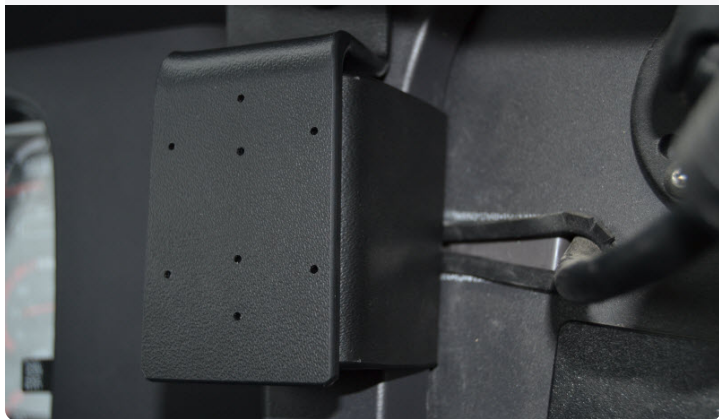
Remove the screw in the dashboard. (See photo)



STEP 2 OF 4

Press the thin end of the enclosed gap opener into the gap between the center instrument panel and the frame of the panel, to widen the gap.

Remove the cover from the adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the hole in the ProClip is at the top.



STEP 3 OF 4

Align the hole in the ProClip with the hole where the screw was taken out. Insert the screw again and tighten it.

Push firmly forward on the right side of the ProClip face plate with your thumb so the right angled edge of the ProClip goes into the gap between the instrument panel and the frame of the panel next to the gap opener.

STEP 4 OF 4

Insert the gap opener between the gauge panel on the left and the frame around the panel. Push firmly forward on the left side of the ProClip face plate with your thumb so the left angled edge of the ProClip goes into the gap between the gauge panel and the frame of the panel next to the gap opener. Pull out the gap opener.

Returns
