GAP OPENER

STEP 1 OF 4

Clean the area where the ProClip will attach.

Press the thin end of one enclosed gap opener into the gap between the padded part of the dash and the center console frame around the information screen, to widen the gap. Insert the lower gap opener just above the silver or chrome strip (see photo) and the second gap opener about three inches above the first opener.



STEP 2 OF 4

Insert part one into the seam/gap between the gap openers. The arrowed notch should be facing to the right. The attaching part with the holes should be pointing to the left over the padded part of the dash.

When part 1 is all the way into the seam, pull out the gap openers.



STEP 3 OF 4

Press the thin end of one enclosed gap opener into the gap between the padded part of the dash and the leather panel surrounding the speedometer, to widen the gap. Insert the L shaped angle edge of part 2 into the seam next to the gap opener. Then be sure to press the L shaped angled edge into the seam while you rotate part 2 to the right. The L shaped edge should hook behind the panel surrounding the speedometer.



STEP 4 OF 4

Align the holes in part 2 with the pre-drilled holes in part 1 and fasten the two parts together with the included screws.

Pull out the gap opener.
