## **STEP 1 OF 4**

Clean the area where the ProClip will attach.

Insert the thin end of the enclosed gap opener into the gap on the inside of the center console storage compartment, to widen the gap.

Remove the cover from the adhesive tape on the ProClip.



## **STEP 2 OF 4**

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position.

Insert the lower edge of the ProClip into the gap next to the gap opener, slide the ProClip leftward so it aligns with the left side of the storage compartment sidewall.



### **STEP 3 OF 4**

Slide the gap opener upward/leftward, widening the gap on the top of the storage compartment. Flex the ProClip downward and insert the upper edge of the ProClip into the gap on top of the storage compartment. Remove the gap opener.

**NOTE** - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



## **STEP 4 OF 4**

The ProClip Mount is in place.

## Returns
