STEP 1 OF 4

Clean the area where the ProClip will attach. The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top.

Hook the angled edge on the lower part of the ProClip over the frame surrounding the air vent, inside the lower part of the air vent.



STEP 2 OF 4

Press the upper part of the ProClip forward and downward.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 3 OF 4

Hook the grooved edge on the upper part of the ProClip under the frame surrounding the air vent.



STEP 4 OF 4

The ProClip Mount is in place.
