STEP 1 OF 4

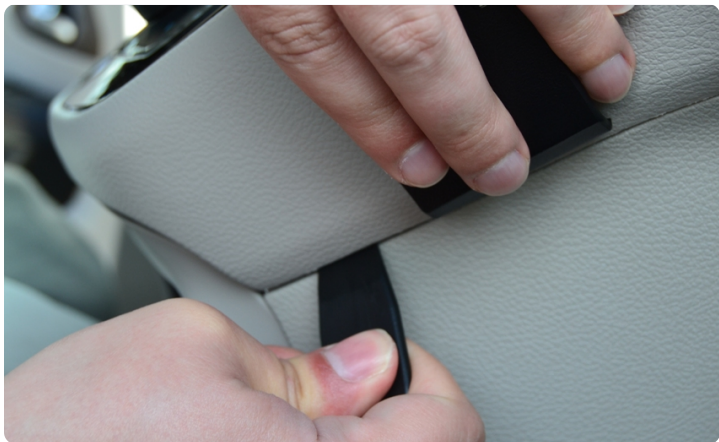
Clean the area where the ProClip will attach. Press the thin end of the enclosed gap opener into the gap between the frame around the stereo and the right center console panel, to widen the gap.



STEP 2 OF 4

The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position. Press the angled edge on the left side of the ProClip into the seam next to the gap opener. Pull out the gap opener.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 3 OF 4

Press the thin end of the gap opener into the gap between the upper console sidewall panel and the lower console sidewall panel, to widen the gap.

Push firmly downward on the right side of the ProClip face plate so the angled lower right edge flexes down and hooks into the seam next to the gap opener.

Pull out the gap opener.



STEP 4 OF 4

The ProClip is in place.
