STEP 1 OF 4

Clean the area where the ProClip will attach. Press the thin end of the enclosed gap opener into the gap/seam between the silver panel around the glove box button and the right center console panel, to widen the gap.

STEP 2 OF 4

The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position. Press the angled edge on the left side of the ProClip into the gap below the gap opener. Pull out the gap opener.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 3 OF 4

Press the thin end of the gap opener into the gap between the console sidewall and the padded part of the dashboard behind the panel, to widen the gap.



STEP 4 OF 4

Push firmly forward on the right side of the ProClip so the angled edge on the right side of the ProClip flexes forward and hooks into the gap next to the gap opener.

Pull out the gap opener.
