## **STEP 1 OF 4**

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the gap/ seam between the upper frame around the information screen and the inside part of the bottom of the center air vent, to widen the gap.

The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position.



## **STEP 2 OF 4**

Press the angled edge on the bottom of the ProClip into the seam next to the gap opener. It might be easier to start with a corner of the ProClip angled edge.

Pull out the gap opener.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



### **STEP 3 OF 4**

Press/flex downward on the upper part of the ProClip, then hook the upper notched edge of the ProClip under the upper vent frame.



## **STEP 4 OF 4**

The ProClip is in place.

## Returns

All returns must be made within thirty (30) days of the delivery date and include proof of purchase, a copy of your original order, or invoice.
