STEP 1 OF 4

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap openers into the gap between the vented panel under the display screen and the padded part of the dash above the clock between the center vents, to widen the gap.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position.

Press the upper thin angled edge of the ProClip into the seam between the gap openers.

Pull out the gap openers.



STEP 3 OF 4

Insert a gap opener into the seam between the panel surrounding the center vents and the black climate control panel.



STEP 4 OF 4

Press downward on the ProClip to flex the lower angled edge down and insert the lower angled edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.
