STEP 1 OF 4

Make sure the air vent is open, with the flaps positioned for straight air flow. Clean the area where the ProClip will attach. The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top.

Place the left edge of the ProClip against the inner left edge of the air vent.



STEP 2 OF 4

Press/ flex the right side of the ProClip leftward.



STEP 3 OF 4

Place the right side of the ProClip against the right inside of the air vent.



STEP 4 OF 4

The ProClip is in place.
