STEP 1 OF 4

Clean the area where the ProClip will attach.

Insert the thin end of the enclosed gap opener into the gap below the trim under the air vent, to widen the gap.

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top.



STEP 2 OF 4

Insert the curved lower edge of the ProClip into the gap next to the gap opener. Push forward on the upper part of the ProClip so the lower curved edge hooks behind the panel.

Pull out the gap opener.



STEP 3 OF 4

Press the gap opener into the gap above the air vent, to widen the gap. Pull the top part of the ProClip upward and hook the angled upper edge into the gap next to the gap opener.

Pull out the gap opener.



STEP 4 OF 4

The ProClip is in place.
