STEP 1 OF 4

Clean the area where the ProClip will attach. The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top.

Press the angled edge on the lower side of the ProClip into the seam between upper frame of the lower center console and the dash panel under the center vents. See photo.



STEP 2 OF 4

Flip/Rotate the ProClip upward so the lower angled edge of the ProClip hooks behind the frame of the lower center console.

Press or flex the upper part of the ProClip downward and insert the thin angled edge into a seam behind the decorative/wood grain panel.



STEP 3 OF 4

The ProClip is in place.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 4 OF 4

The ProClip Mount is in place.
