GAP OPENER

STEP 1 OF 4

Clean the area where the ProClip will attach. Insert the thin end of the enclosed gap opener into the gap/seam between the two panels to the right of the climate control frame. (See photo for location.), to widen the gap.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 2 OF 4

Keep a hold on the gap opener and, at the same time, insert the angled lower edge of the ProClip into the gap next to the gap opener.

Pull out the gap opener.



STEP 3 OF 4

Insert the thin end of the gap opener into the gap above the air vent, to widen the gap. Pull the upper part of the ProClip upward/forward and insert the angled upper edge into the gap next to the gap opener.

Remove the gap opener.



STEP 4 OF 4

The ProClip is in place.
