STEP 1 OF 4

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the gap between the upper center vent and the frame around the vent, to widen the gap.

The adhesive tape covers need to be removed.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position. Insert the top of the ProClip all the way into the top of the vent until the tab on the ProClip rests on the front of the padded part of the dash.

NOTE - The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 3 OF 4

Flex the lower part of the ProClip upward and insert the lower thin edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.



STEP 4 OF 4

The ProClip is in place.

The ProClip will attach any place along the upper center vent area.

Returns
