STEP 1 OF 4

Clean the area where the ProClip will attach. Press the two thin ends of the enclosed gap openers into the gap between the right side of the stereo frame and the center console side panel, to widen the gap. See photos. keep the gap openers about 2 inches apart

Remove the adhesive tape cover on the smallest of the two ProClip mount parts. (Part one)



STEP 2 OF 4

Press the thin angled edge on part one into the seam between the gap openers. The tape should be on the right side of the mount or closest to you when inserting the mount into the seam. Rotate part one to the right so the tape attaches to the dash panel on the right.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 3 OF 4

Remove the adhesive tape cover on the larger of the two ProClip mount parts. (Part two) Align the larger holes on the face plate of part two up with the holes on part one. Once aligned, press the tape on the left side of part two onto the dash. Then, use the two larger included screws to attach the two parts together.



STEP 4 OF 4

The ProClip is in place.

Returns
