GAP OPENER



Attention:

STEP 1 OF 4

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the gap between the upper center console right side wall frame and the panel framing the radio and display, to widen the gap.

The adhesive tape cover must be removed.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top. Insert the left edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.



STEP 3 OF 4

Insert the gap opener into the seam between the upper center console right side wall frame and the panel below it. (See photo for location.) This is a very tight seam so use two gap openers if needed.



STEP 4 OF 4

Press down and, at the same time, press inward on the right side of the ProClip to insert the thin right edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.

Returns
