STEP 1 OF 4

Clean the area where the ProClip will attach. Press the thin end of the enclosed gap openers into the gap between the padded top of the right side of the center console and the plastic panel below it and to the right of the center vent, to widen the gap.

STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is on the right side.

Press the thin angled edge on the left side of the ProClip into the gap between the gap openers.

The seam will be tight but the mount should insert into the seam. **Attention:**

Take some caution with the edges of the ProClip because the padded leather is soft.



STEP 3 OF 4

Place your fingers inside the right side of the ProClip and flex the ProClip over the top of the padded right side of the center console. Insert the thin right edge of the ProClip into the gap between the padded top and the plastic panel below it. The flex will be firm so the mount will fit securely.

Pull out the gap openers.



STEP 4 OF 4

The ProClip is in place.

Returns
