DO NOT attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash.

STEP 1 OF 4

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the gap between the panel behind the center vents and the dash panel just in front of the display/information screen, to widen the gap.

The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position.



STEP 2 OF 4

Insert the lower edge of the ProClip, behind the face plate, into the top of the vent opening.

NOTE - The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 3 OF 4

Hold the mount up and, at the same time, press forward on the ProClip to flex the front edge of the mount into the seam next to the gap opener.

Pull out the gap opener.



STEP 4 OF 4

The ProClip is in place.
