STEP 1 OF 4

Clean the area where the ProClip will attach. Insert the gap opener into the seam between the frame around the display and the padded dash top under the display to widen the seam.



STEP 2 OF 4

Place the ProClip in your hand so the ProClip label (sticker) is at the top.

Insert the bottom edge of the mount into the seam between the climate control panel and the padded dash above the panel.



STEP 3 OF 4

Rotate the mount upward and forward. Then lift the front of the mount and insert it into the seam next to the gap opener.



STEP 4 OF 4

Press the top of the mount into the seam.
