## **STEP 1 OF 4**

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the seam between the left side of the chrome trim on the right side of the top of the console edge and the inner center console panel, to widen the gap. See photo.

**NOTE** - The tape does not leave any marks or damage the dashboard, and is easy to remove.



## **STEP 2 OF 4**

The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position. Insert the thin left edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.



### **STEP 3 OF 4**

Insert the gap opener into the seam on the right side of the chrome trim on the right side of the top of the console edge and the outer center console panel, to widen the gap. See photo.



## **STEP 4 OF 4**

Press the ProClip to the right and insert the thin right edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.

## Returns
