STEP 1 OF 5

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the gap between the panel above the SYNC and defrost buttons and the padded dash above the buttons, to widen the gap.



STEP 2 OF 5

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top.

Insert the thin lower edge of the ProClip into the seam next to the gap opener.



STEP 3 OF 5

Pull the top of the ProClip upward and over the padded part of the dash.



STEP 4 OF 5

The ProClip is in place.



STEP 5 OF 5

Press forward on the mount until the thin front edge goes into the seam between the display and the padded dash.

Returns
