STEP 1 OF 5

Clean the area where the ProClip will attach. Insert the thin end of the gap opener into the seam between the padded center panel of the dash and the plastic panel surrounding the climate control panel, to widen the gap. See photo.



STEP 2 OF 5

The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is at the top.

Insert the lower edge of the ProClip into the seam next to the gap opener.



STEP 3 OF 5

Flex the ProClip upward and forward to hook the top angled edge over the padded dash panel.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 4 OF 5

Press down on the top of the ProClip to make sure the mount goes all the way into the seam.



STEP 5 OF 5

The ProClip is in place.
