GAP OPENER

STEP 1 OF 5

Clean the area where the ProClip will attach. Press the thin end of the enclosed gap opener into the gap between the right center console panel and the padded dash top above it, to widen the gap.

STEP 2 OF 5

The adhesive tape cover must be removed. Insert the thin lower edge of the mount into the seam next to the gap opener. When the lower edge is all the way into the seam, rotate the mount upward.

Pull out the gap opener.



STEP 3 OF 5

Press the thin end of the gap opener into the gap between the padded dash top and the black trim piece separating the upper and lower dash.



STEP 4 OF 5

Press the thin upper edge of the mount into the seam next to the gap opener.

Pull out the gap opener.



STEP 5 OF 5

The ProClip is in place.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.

Returns
