STEP 1 OF 5

Press the thin end of the enclosed gap openers into the gap between the center console panel right edge and the padded dash to the right of the console panel.



STEP 2 OF 5

Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top.

Press the angled edge on the right side of the ProClip into the gap by the gap openers.

Pull out the gap openers.



STEP 3 OF 5

Press the thin end of the gap openers into the gap between the console frame and the right edge of the frame around the display. See photo.



STEP 4 OF 5

Press the left edge of the ProClip into the seam next to the gap openers.



STEP 5 OF 5

The ProClip is in place.

Returns
