STEP 1 OF 5

Clean the area where the ProClip will attach.

Press the thin end of the enclosed gap opener into the gap between the console top and the lower part of the cup holder, to widen the gap.



STEP 2 OF 5

The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position. Press the edge of the ProClip into the seam next to the gap opener.

Pull out the gap opener.



STEP 3 OF 5

Insert the gap opener into the front seam between the top of the center console and the front of the console.



STEP 4 OF 5

Press forward on the ProClip to flex the front edge into the seam next to the gap opener.



STEP 5 OF 5

The ProClip is in place.

NOTE - The tape does not leave any marks or damage the dashboard, and is easy to remove.
