STEP 1 OF 4

Clean the area where the ProClip will attach. The adhesive tape cover must be removed. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position / the P in ProClip is at the top.

Insert the thin right edge of the ProClip into the seam between the vent frame and the padded dash to the left of the vent frame. Use the gap opener if needed to open the seam.



STEP 2 OF 4

Press forward on the left side of the ProClip to press the left edge of the ProClip into the seam between the clear speedometer panel and the frame around the panel.



STEP 3 OF 4

The ProClip is in place.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



STEP 4 OF 4

The ProClip is in place.
